Climate Proofing of Agricultural Infrastructure and Business-Focused Adaptation

Climate-Resilient Rice Commercialization Sector Development Program (ADB Loan Nos. 3006, 3007, and 8271; Grant Nos. 0349 and 0350)

OUTCOME

Enhanced production of high-quality rice in Cambodia while preserving the natural resource base

OUTPUT

- Legal and regulatory environment facilitating climateresilient rice commercialization established
- Agricultural land-use zoning improved
- Climate-resilient rice value chain infrastructure developed
- Rice value chain support services to improve quality of Cambodian rice enhanced
- Weather-indexed crop insurance pilot-tested

ADAPTATION ACTIVITIES

- Rehabilitation of irrigation infrastructure (reservoirs, delivery and drainage canals) to make it climate resilient
- Construction of climate-resilient paddy and seed drying and storage facilities
- Demonstration of laser land leveling for water conservation and more efficient water use
- Pilot-testing of weather-indexed crop insurance in three provinces
- Capacity building of mill managers and operators to strengthen climate resilience
