BUR Project Information

Project title:	Preparation of the First Biennial Update Report to the United Nations Framework Convention on Climate Change (UNFCCC)
Project executing organization:	General Secretariat of National Council for Sustainable Development/Ministry of Environment
Duration of project:	24 months
Commencing:	October, 2017
Completion:	September, 2019 (extended to 30 April 2020)
Project Cost:	 Cost to GEF Trust Fund 342,000\$ (94.5%) Government in-kind contribution 20,000\$ (5.5%)





BUR Project Information

- The main actors provided for its management framework are:
 - ➤ Implementer: General Secretariat of National Council for Sustainable Development, Department of Climate Change (main entity designated for planning, preparation and management of national communications and biennial update reports);

- ➤ Other line ministries through the Climate Change Technical Working Group (CCTWG);
- Funding: Global Environment Facility (GEF) through the United Nations Environment Programme (UN Environment).





Project objectives

1 General Objective

➤ The general objective of the project is to improve technical capacity and institutional arrangements of Cambodia for the elaboration of national communications and biennial update reports under UNFCCC.

2 Specific objectives

- ➤ Specific Objective 1: Strengthen national technical and institutional capacities for the preparation of biennial update reports.
- ➤ Specific Objective 2: Update data and information reported in the previous national communications, particularly SNC, related to, inter alia, greenhouse gas inventories, mitigation actions and their effects and information on support received for the preparation and submission of the FBUR.
- ➤ Specific Objective 3: Elaborate the FBUR for Cambodia in accordance with decisions 1/CP.16 and 2/CP.17 of the Conference of Parties to the UNFCCC.





BUR Preparation

- Preparation of a comprehensive First Biennial Update Report (FBUR) in Cambodia continues to represent a challenging task.
- Although institutional reforms have been implemented recently for climate action, many functions and data remain unavailable and had to be developed in the process.
- Additional studies had to be conducted to produce essential information about current emissions, options for mitigation and support needed and received.





BUR Preparation: The nurtured sustainability of the project

• The project provided:

- Capacity building and Institutional strengthening (Several workshops provided, oversea training and workshop)
- Staff have more confident and are able to defend and share the results of the assessment
- Active participation for the project implementation from the line ministries and relevant stakeholders
