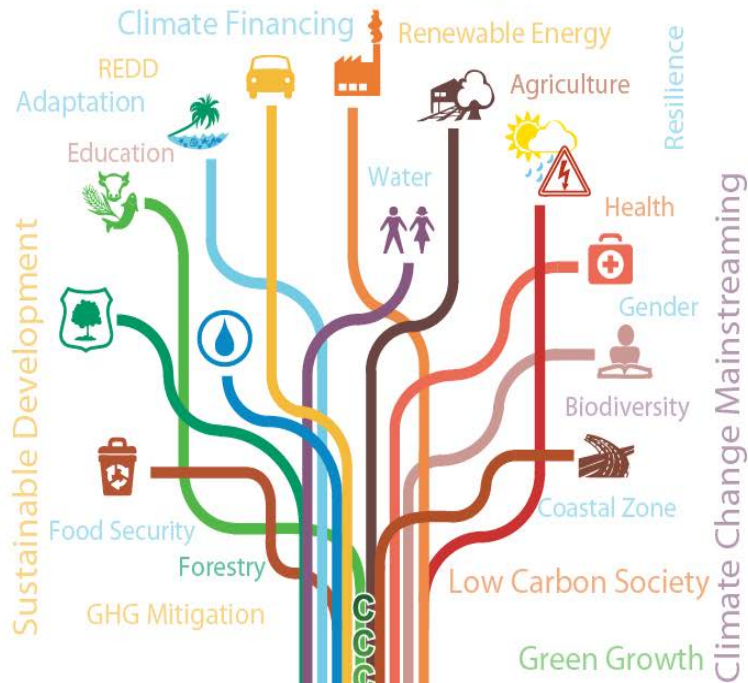

MoWA is the national machinery for promotion of gender equality and empowerment of women.

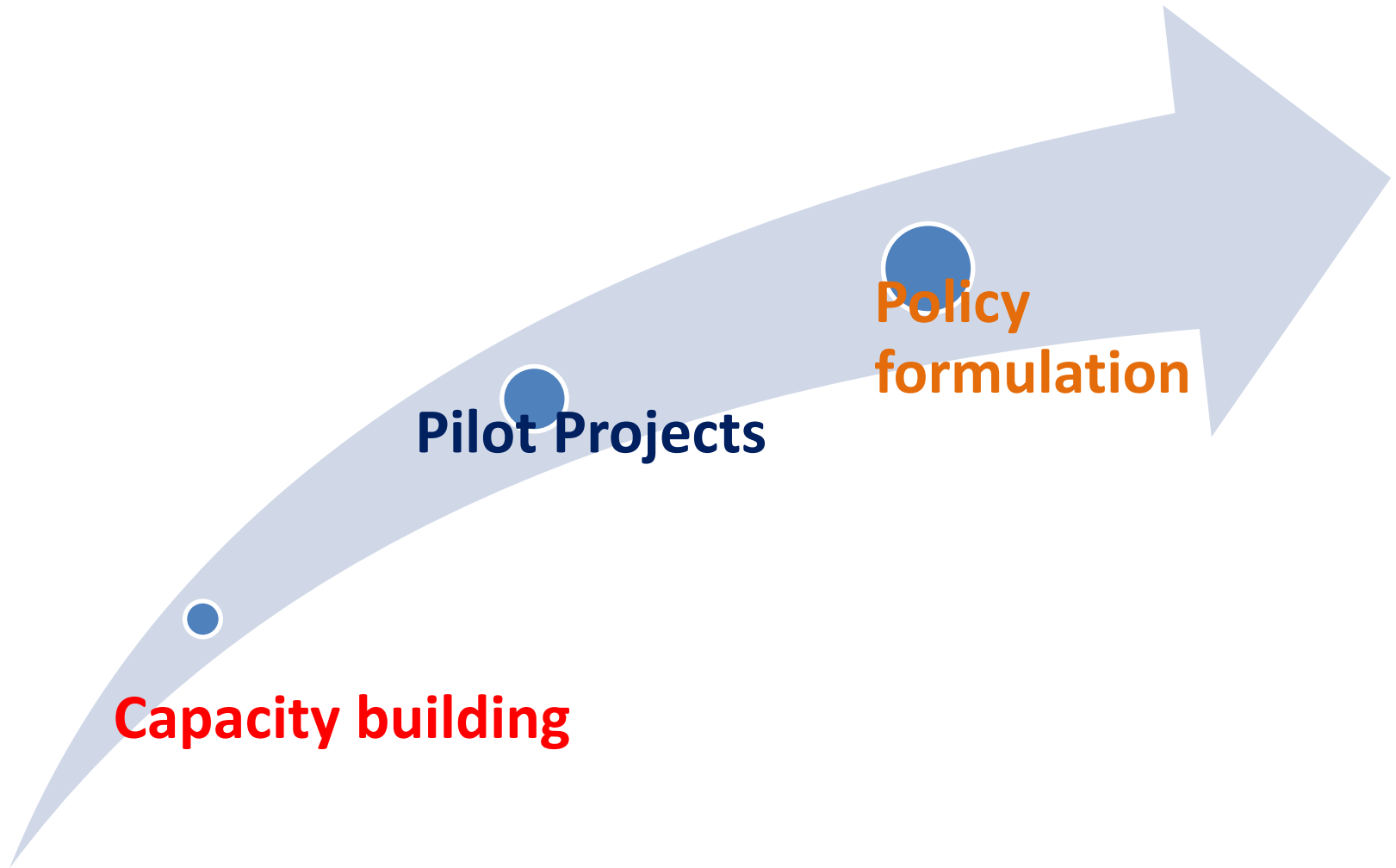
As part of its sector support, the MoWA commits in its 5-years strategic plan, Neary Rattanak 3, to address gender in all national climate change adaptation and mitigation policies & strategies.



The Policy and Mechanism

- MoWA established **Gender and climate change committee-GCCC** in late **2011** to address gender in Climate change.
 - **Its members are from various departments**
- **Gender Mainstreaming action Group in Line Ministries**
 - **22 Ministries have developed Gender Mainstreaming Action Plan (GMAP)**
 - **16 Ministries have received budget allocation from government and Development Partners to implement their activities.**

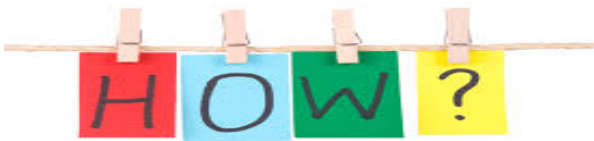
