Definition

- An initiative/intervention to implement a strategy of the Climate Change Strategic Plan (CCSP) (action-oriented);
- Relates to a specific climate change risk or opportunity;
- Could be implemented through one or several projects/programs;
- With clear and measurable products;
- Can be technical assistance, policy/legal reforms, recurrent expenditure or capital investment.

Categories

- Category 1: Dedicated climate change interventions (to deal with unaddressed CC issues);
- Category 2: Climate proofing of existing activities (addressing the adaptation and mitigation gap through modifications or additions to existing interventions);
- Category 3: Re-scaling of existing and planned interventions based on their climate change dimension.

Type

- Mitigation/low carbon development
- Adaptation
- Combined mitigation and adaptation

How are the actions identified?

- Category 1: from CCSP and sector development strategies (conduct double check against 2nd National Communication)
- Category 1 and 2: from the review of existing plans/budgets (Public Investment Plan, AWP, ministry budget) to ensure all climate-relevant existing/planned actions are integrated
- Identification process should be participatory

Example of Actions

Actions Related to Existing Initiatives/interventions (Category 2-3)

- Climate-proof Design of North-West Irrigation Infrastructures
- Climate-proof Assessment of Seawall and Drainage Infrastructure in Coastal Provinces of Cambodia
- Up-scaling and Improvement of the Early Warning System in Disaster and Extreme Weather-Prone Areas of Cambodia
- Replication of Capacity Building of FWUCs in Community-Based Disaster Preparedness in Irrigation Projects
- Up-scaling Malaria Surveillances in all Provinces of Cambodia

Example of Actions, cont.

Actions based on Ministry's CCSP (Category 1)

- Capacity Development for GHG Inventory and Accounting in Energy and Manufacturing Industries in MIME
- Assessment and Development of Fiscal Policy and Reform for Renewable Energy Development in Cambodia
- Piloting Saline Resistant Rice Varieties in Coastal Provinces of Cambodia
- Capacity Development for Climate Proof Infrastructure Development in Transport Sector
- Development of Climate Change Courses for Colleges and Universities in Cambodia
- Capacity Building of FWUCs in Agricultural Diversification to Adapt to Climate Change Impacts and Risks.

Preparatory Steps

- Letter of Agreement between National Climate Change Committee (NCCC) and Line Ministries
- Readiness of Focal Points and Working Groups of line ministries to lead the process. Planning department and other relevant technical departments of the line ministry should be involved in the process.
- An agreed Workplan with responsibility and timeline between technical supporting team and working groups (a kick-off meeting between consultants and working groups should be planned now).

- Assigning Reporter
- Facilitator (sector consultant)
- Refreshing Climate Risks , GHG mitigation, and CCSP
- Based on PIP and recurrent expenditure by sector, brainstorming for up-scaling or proofing actions

- Points to be reported back:
 - Climate risks
 - Actions up scaling or proofing existing projects or programs
 - New actions based on climate risks and CCSP
