

Engagement under UNFCCC

Cambodia's commitments

- Parties to the UNFCCC, Kyoto Protocol, accepted Doha Amendment for Kyoto second commandment period, Signatory of Climate Change Paris agreement
- Submitted First and Second National Communication, National Adaptation Program of Action, Intended Nationally Determined Contribution, (Available in both UNFCCCC Website and National Climate Change Website)
- National Assembly voted to unanimously on the Draft Law of Climate Change Paris Agreement on 23 Nov 2016.

South-South Cooperation and Partnerships

- State visit of Nepalese delegates to Cambodia in July 2016
- Participated in regional forum, ASEAN
- Cambodia became a member of International Solar Alliance in COP 22
- Discussion to participation in South-South Cooperation initiative with China.







Engagement under UNFCCC (Cont)

Technology Transfer

- Technology Need Assessment, Technology Action Plan (TAP)
- 2 Joint Crediting Mechanism (JCM), 12 Cleaner Development Mechanism (CDM).

Climate Finance

- Cambodia has mobilized climate finance about USD 80 million., annually
- Source of support, GEF, LDCF, Bilateral support (EU, Sweden, UNDP, Climate Investment Fund, ADB, IFAD, and others).
- New source: Green Climate Fund (GCF)
- Prepare for National Accreditation for GCF
- Cambodia has prepared Climate Change Financing Framework, Annual Public Climate Change Expenditure Review, tracking climate change finance in ODA system

Capacity Development

- Focus on all level of stakeholders
- Produced training, awareness raising materials, online sharing platform
- Education Curriculum for Secondary, High School and University level
- For example: Training to 9 ministries on Climate Change Policy and Public Finance (UNITAR, EFI/MEF, and CCCA)

Policy Response

Cambodia Climate Change Strategic Plan 2014-2023 is the first comprehensive strategic plan for Cambodia.

14 line ministries have operationalized the CCCSP into their sector Climate Change Action Plan (CCAP)


