




Background of the National Forum

The First National Forum on Climate Change was successfully held in October 2009.

The event sought to raise the awareness of climate change as a development challenge and to profile the growing activities, both nationally and internationally, to decision makers, donors and practitioners. The Forum was opened by the Prime Minister and received good support from multiple donors with broad participation of over 700 representatives from all sectors.

The National Climate Change Committee of Cambodia (NCCC)

The NCCC regroups all line ministries to work together to combat Climate Change in Cambodia.

The NCCC is the main body of the Forum. Its functions are to:

- Implement Climate Change Activities
- Develop policy, strategies and action plan
- Mainstream climate change
- Enhance collaboration with all key stakeholders both nationally and international

Forum Facilitator

The Climate Change Department (CCD) of the Ministry of Environment is the main facilitator of the second national forum on Climate Change. The CCD is the secretariat of the NCCC. It plays a key role in climate change action in Cambodia.
